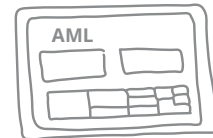

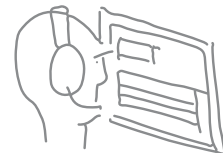

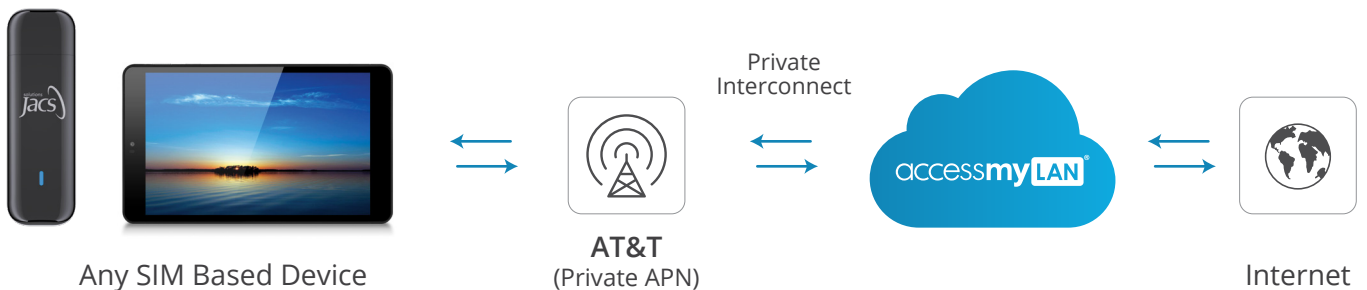

Productivity Management

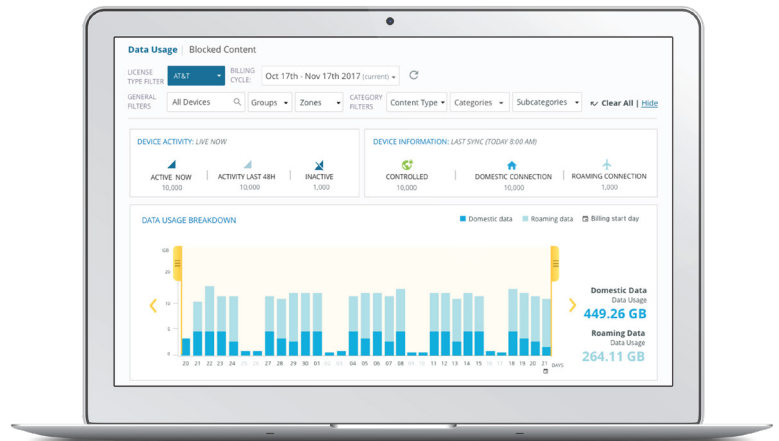
